Truck accidents on major corridors like Interstate 285 in the Atlanta metropolitan area continue to pose significant risks to motorists. The complexity of determining liability in these cases requires thorough investigation of multiple factors, including driver qualification files, hours-of-service logs, maintenance records, and freight-broker contracts.

"When trucking companies are only required to maintain driver logs for six months, every day counts for accident victims," said Zachary S. Shewmaker, partner at Horst Shewmaker, LLC. "We've seen cases where critical evidence disappeared because victims waited too long to seek legal representation. Our immediate priority in any truck accident case is to send preservation letters to prevent the destruction of electronic logging device data, dashcam footage, and other time-sensitive evidence."

This includes obtaining driver qualification files that reveal hiring practices, training records, and previous violations that might indicate negligent retention.
